RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSAL TO REALLOCATE CERTAIN UNSPENT PROCEEDS OF THE GENERAL OBLIGATION BONDS, TAXABLE SERIES 2009G, THE GENERAL OBLIGATION BONDS, SERIES 2010D, AND THE GENERAL OBLIGATION BONDS, TAXABLE SERIES 2010E, OF THE CITY OF DES MOINES, IOWA, AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, pursuant to hearings duly held under Iowa Code Section 384.26(5) and Roll Call No. 09-1004 approved on June 8, 2009, the City Council of the City of Des Moines, Iowa has previously issued its General Obligation Bonds, Taxable Series 2009G, in the aggregate principal amount of \$3,115,000 (the "Series 2009G Bonds"), for the purpose, among other things, of defraying all or a portion of the costs of rebuilding of the gibbon and macaque exhibits at Blank Park Zoo, and the acquisition of real property for the relocation of a portion of Blank Park Golf Couse; and

WHEREAS, pursuant to a hearing duly held under Iowa Code Section 384.26(5) and Roll Call No. 10-944 approved on June 14, 2010, the City Council of the City of Des Moines, Iowa has previously issued its General Obligation Bonds, Series 2010D, in the aggregate principal amount of \$25,330,000 (the "Series 2010D Bonds"), for the purpose, among other things, of defraying all or a portion of the costs of the construction, equipping and improving of the sea lion exhibit at Blank Park Zoo; and

WHEREAS, pursuant to a hearing duly held under Iowa Code Section 384.26(5) and Roll Call No. 10-945 approved on June 14, 2010, the City Council of the City of Des Moines, Iowa has previously issued its General Obligation Bonds, Taxable Series 2010E, in the aggregate principal amount of \$2,260,000 (the "Series 2010E Bonds"), for the purpose, among other things, of defraying all or a portion of the costs of the improvement of Blank Park Zoo; and

WHEREAS, certain proceeds of the Series 2009G Bonds, the Series 2010D Bonds and the Series 2010E Bonds remain unspent, and the City Manager has recommended that not to exceed \$3,200,000 of such unspent proceeds (the "Unspent Proceeds") be applied for the purpose of funding one or more economic development grants to the Blank Park Zoo Foundation, to be used in accordance with a Lease Agreement and an Economic Development Agreement between the City of Des Moines and Blank Park Zoo Foundation (the "Zoo Foundation Grants"); and

WHEREAS, there being no procedure specified under Iowa law for consideration or approval of such a reallocation, it is hereby determined, pursuant to Section 364.6 of the Code of Iowa, that the procedure set forth in Section 384.25 of the Code of Iowa should apply to such proposal, and that a hearing be held upon the proposal to reallocate the Unspent Proceeds to provide funds for the Zoo Foundation Grants.
