## **DES MOINES TRAFFIC REGULATION CHANGES**

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Removal of former Central Library Parking Lot from the Municipal Code.
- B. Additional Handicapped Parking Spaces on High Street between 10th Street and 11th Street.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by repealing Section 114-670 and amending Section 114-3307, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by repealing

Section 114-670 and amending Section 114-3307 relating to traffic and vehicle regulations, as

follows:

## Sec. 114-670. <u>Repealed by Ord. No. 15,---.</u> Second Avenue and Walnut Street Municipal Parking Lot.

(a) The city engineer is hereby authorized and directed to install parking meters in the following described municipally-owned parking lot:

A tract of land bounded on the west by the east line of Second Avenue; on the north by the south line of Locust Street; on the east by the west line of Library Street and on the south by the north line of Walnut Street; in the City of Des Moines, Iowa, for the purpose of, and in such numbers, and at such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.

(b) When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Mondays through Fridays. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed in Parking Meter District I, as is found in section 114-643 of this code.

Parking meter LI-L-51 and LI-L-52 ten hour meters, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are subject to the same prohibition as is found in section 114-616(a) of this code.

## Sec. 114-3307. High Street--Tenth Street to Eleventh Street.

High Street, on the north side, from Tenth Street to a point 25 feet west thereof, no parking any time.

High Street, on the north side, from a point 255 feet west of Tenth Street to a point 70 feet west thereof, no parking any time.

<u>High Street, on the north side, parking meter H-1000 A/B, a ten-hour double meter, 8:00 a.m.</u> to 6:00 p.m., are designated as handicapped parking spaces and are subject to the same prohibition as is found in section 114-616(a) of this code. <u>High Street, on the south side, parking meter H-1001 A/B, a ten hour double meter, 8:00 a.m.</u> to 6:00 p.m., are designated as handicapped parking spaces and are subject to the same prohibition as is found in section 114-616(a) of this code.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
