## HEARING FOR CONVEYANCE OF AN UNDERGROUND ELECTRIC LINE EASEMENT ON CITY-OWNED PROPERTY LOCATED AT SE 9<sup>TH</sup> STREET AND JACKSON AVENUE TO MIDAMERICAN ENERGY COMPANY FOR THE JACKSON AVENUE DETENTION BASIN PUMP STATION FOR \$1

WHEREAS, MidAmerican Energy Company ("MidAmerican") electric transmission lines are required for electric service for the Jackson Avenue Detention Basin Pump Station project, and thus MidAmerican has requested an underground electric line easement across City-owned property for this project; and

WHEREAS, the City of Des Moines needs to grant the requested easement to allow completion of the aforementioned project and to provide electrical service to the City facility, and, if approved, the underground electric line easement will be terminable and conditional upon the use of said easement by MidAmerican to provide electricity to the City; and

WHEREAS, on March 28, 2011, by Roll Call No. 11-0515, it was duly resolved by the City Council that the proposed conveyance of the easements be set down for hearing on April 11, 2011, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal to convey the easement was given as provided by law, setting forth the time and place for hearing on the proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, the objections to the proposed conveyance of these easements, as described below, are hereby overruled and the hearing is closed.
- 2. The public would not be inconvenienced by reason of the conveyance of a 10-foot underground electric line easement to MidAmerican Energy Company across City-owned property locally known as SE 9<sup>th</sup> Street and Jackson Avenue to provide electrical service for the Jackson Avenue Detention Basin Pump Station, more specifically described as follows, for \$1, and said conveyance is hereby approved:
