RESOLUTION APPROVING AN AGREEMENT WITH GREATER DES MOINES HABITAT FOR HUMANITY FOR PURCHASE OF REAL ESTATE WHEREBY CITY AGREES TO ACQUIRE 1144 17TH STREET AND 3017 MAHASKA AVENUE BY TAX SALE DEED AND CONVEY FOR CONSTRUCTION AS AFFORDABLE HOUSING

WHEREAS, the real estate located at 1144 17th Street, more specifically described as follows:

Legal: Lot 10 Block 2 Harlan Park, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

contains a vacant lot assessed as residential property suitable for redevelopment for housing use; and the real estate at 3017 Mahaska Avenue, more specifically described as follows:

Legal: Lot 12, Block 9 Hyde Park Plat Number 2, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

contains a vacant lot assessed as residential property suitable for redevelopment for housing use (such real estate is referred to as "Parcels"); and,

WHEREAS, pursuant to Iowa Code §446.19A, on June 14, 2010 by Roll Call 10-920, the City Council authorized the City Manager to request the removal of Parcels from Polk County tax sale and to approve assignment of tax sale certificates to Greater Des Moines Habitat For Humanity, Inc. for development of low to moderate income owner-occupied housing; and,

WHEREAS, Greater Des Moines Habitat for Humanity has agreed to pay for a Special Council to represent the City in acquiring the tax deed and all associated costs and expenses; and

WHEREAS, there is no known current or future public need for the Property proposed to be acquired and sold and the City will not be inconvenienced by the acquisition and sale of such Property; and

WHRERAS, the Parcels are both encumbered with liens for substantial amounts of special assessments. For such liens to be cleared in a manner that does not permit the current owners to redeem the Parcels from the tax sale without payment of such special assessments it is necessary that the City take title to the Parcels by tax deed; and

WHEREAS, on April 11, 2011 by Roll Call No. 11-0586, it was duly resolved by the City Council that the proposed Agreement and conveyance of such Parcels be set down for public hearing on April 25, 2011 at 5:00 pm, in the Council Chambers; and

- 1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed Agreement and conveyance of real estate as described above are hereby overruled and the hearing is closed.
- 2. Agreement for Purchase of Real Estate described above is hereby approved. The Mayor is hereby authorized and directed to sign the Agreement on behalf of the City of Des Moines and the City Clerk is hereby authorized and directed to attest to the Mayor's signature on such document.
- 3. If the City receives title to the Parcels by tax deed as provided in the Agreement, the Mayor is hereby further authorized and directed to sign the Quit Claims on behalf of the City of Des Moines to convey such Parcels to Greater Des Moines Habitat for Humanity as provided in the Agreement, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature on such documents.
