RESOLUTION APPROVING SEVERANCE OF THE WESTERN PORTION OF COPPER CREEK LAKE PARK FOR ANNEXATION INTO PLEASANT HILL

WHEREAS, the City of Pleasant Hill is the owner of the Property described below, and has requested that the Property be severed from the City of Des Moines for annexation into the City of Pleasant Hill:

A parcel in the Southeast Quarter of Section 33, Township 79 North, Range 23 West of the 5th P.M., in the City of Des Moines, Polk County, Iowa, described as Parcel E in the Corrected Plat of Survey filed on April 24, 2000, in Book 8478, at Page 618, containing 27.700 acres, more or less, and herein referred to as the "Property".

WHEREAS, on November 22, 2010, by Roll Call No. 10-1935, the City Council authorized and directed the City Manager to proceed with negotiations with Pleasant Hill for the severance of the Property for annexation into Pleasant Hill, upon terms consistent with the recommendations set forth in Council Communication No. 10-707; and,

WHEREAS, consistent with the recommendations set forth in Council Communication No. 10-707, the City Manager has obtained a commitment from Pleasant Hill, memorialized in a Declaration of Covenants now on file with the City Clerk, to limit the sound levels that can be generated by any activity upon the Property if it becomes part of the City of Pleasant Hill; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council hereby makes the following findings:
 - a) The Property is located within the City of Des Moines and adjacent to the shared boundary between the cities of Des Moines and Pleasant Hill, as shown by the map attached hereto as Exhibit "A".
 - b) The Property is tax exempt, owned by the City of Pleasant Hill, and devoted to public use as the western portion of Copper Creek Lake Park.
 - c) The Property requires police and emergency services from the City of Des Moines, but does not contribute to the City of Des Moines tax base or revenues.
 - d) The City of Pleasant Hill has agreed that if it is allowed to annex the Property, it will limit the sound levels that can be generated by any activity upon the Property to conform with the Declaration of Covenants described above.
- 2. The severance of the Property described above from the City of Des Moines is hereby approved, subject to, and to be effective upon, the annexation of the Property by the City of Pleasant Hill.
