

We Somali community have been following carefully the hearings and the case of City Cab including the last public hearing in City Hall of Des Moines April 11 2011. It was sad and sorrowful what some City Cab former drivers did in the City Hall against company's LLC owners on above mentioned date.

After deep investigation and several attempts that Somali community leaders and its members tried to know the fact of City Cab former drivers accusations against the City Cab LLC owners, we found out that all the accusations were false accusation.

Fact finding mission assigned by the president of the community questioned both City Cab LLC owners and its former drivers to make sure the bone of the argument and the reality of the former City Cab drivers accusations to their employer to scale down the tension and solve the problem through community mediation.
