AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1434, 114-2636 and 114-3342, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-1434, 114-2636 and 114-3342 relating to traffic and vehicle regulations, as follows:

## Sec. 114-1434. Cleveland Avenue.

Cleveland Avenue and East Ninth Street, school signal.
Cleveland Avenue and East Fourteenth Street, school signal.

## Sec. 114-2636. Southeast Fifth Street--East Vine Street to East County Line Road.

Southeast Fifth Street, on the west side, from East Market Street to East Elm Street, parking for city vehicles only.

Southeast Fifth Street, on the west side, from East Elm Street to Shaw Street, no parking any time.

Southeast Fifth Street, on the east side, from a point 75 feet south of East Elm Street to a point 85 feet south thereof, no parking any time.

Southeast Fifth Street, on both sides the east side, from East Livingston Avenue to East Jackson Avenue, no parking any time.

Southeast Fifth Street, on both sides, from East Jackson Avenue to East Granger Avenue, no stopping or standing.

Southeast Fifth Street, on both sides, from Hartford Avenue to East Bell Avenue, no parking any time.

Ingersoll Avenue, on the south side, from Fourteenth Street to Martin Luther, King, Jr Parkway, no parking any time.

Ingersoll Avenue, on the north side, from Fourteenth Street to Eighteenth Street, no parking any time.

Ingersoll Avenue, on the north side, from Eighteenth Street to a point 300 feet east of Martin Luther King Jr Parkway, no parking 4:00 p.m. to 6:00 p.m.

Ingersoll Avenue, on the north side, from a point 50 feet east of Nineteenth Street to a point 50 feet west of Nineteenth, no parking any time.

Ingersoll Avenue, on the north side, from a point 50 feet west of Nineteenth Street to a point 300 feet east of Martin Luther King Jr Parkway, two-hour parking 9:00 a.m. to 4:00 p.m.






