PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2011 CITY-WIDE PCC PAVEMENT RESTORATION PROGRAM; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS ABSOLUTE CONCRETE CONSTRUCTION, INC., SONNY E. HALL, PRESIDENT, \$213,870.00

WHEREAS, on May 23, 2011, under Roll Call No. 11-0862, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2011 City-wide PCC Pavement Restoration Program, 06-2011-009

The improvement includes furnishing, placing, curing, sawing, and sealing PCC Pavement Patches of various thickness in a cooperative effort with the City of Des Moines, Public Works Department, at the following locations:

- E. 42nd Street from Hubbell Avenue to Boyd Street
- SW 62nd Street from Tonka Avenue to Railroad Avenue
- Adams Avenue from 34th Street to dead-end East
- E. Douglas Avenue from E. 38th Street to E. 42nd Street
- Kingman Circle from Kingman Boulevard to cul-de-sac South
- SW Leland Avenue from Hwy 28 to SW 63rd Street
- Park Lawn Avenue from SW 42nd Street to 1600' West
- E. Rose Avenue from SE 15th Street to Indianola Drive
- Twana Drive from 50th Street to 4928 Twana Drive
- Walker Avenue from E. 29th Street to E. 30th Street

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Absolute Concrete Construction, Inc., Sonny E. Hall, President, PO Box 148, Slater, IA, 50244 in the amount of \$213,870.00, and said bid be and the same is hereby accepted.

BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.

BE IT FURTHER RESOLVED: That the Engineer is hereby directed to secure execution by the lowest responsible, responsive Bidder and its surety of the contract documents in the form heretofore approved by this Council; that the Engineer is directed to thereafter present said contract documents to this Council for approval and authorization to the Mayor to sign; and that no contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

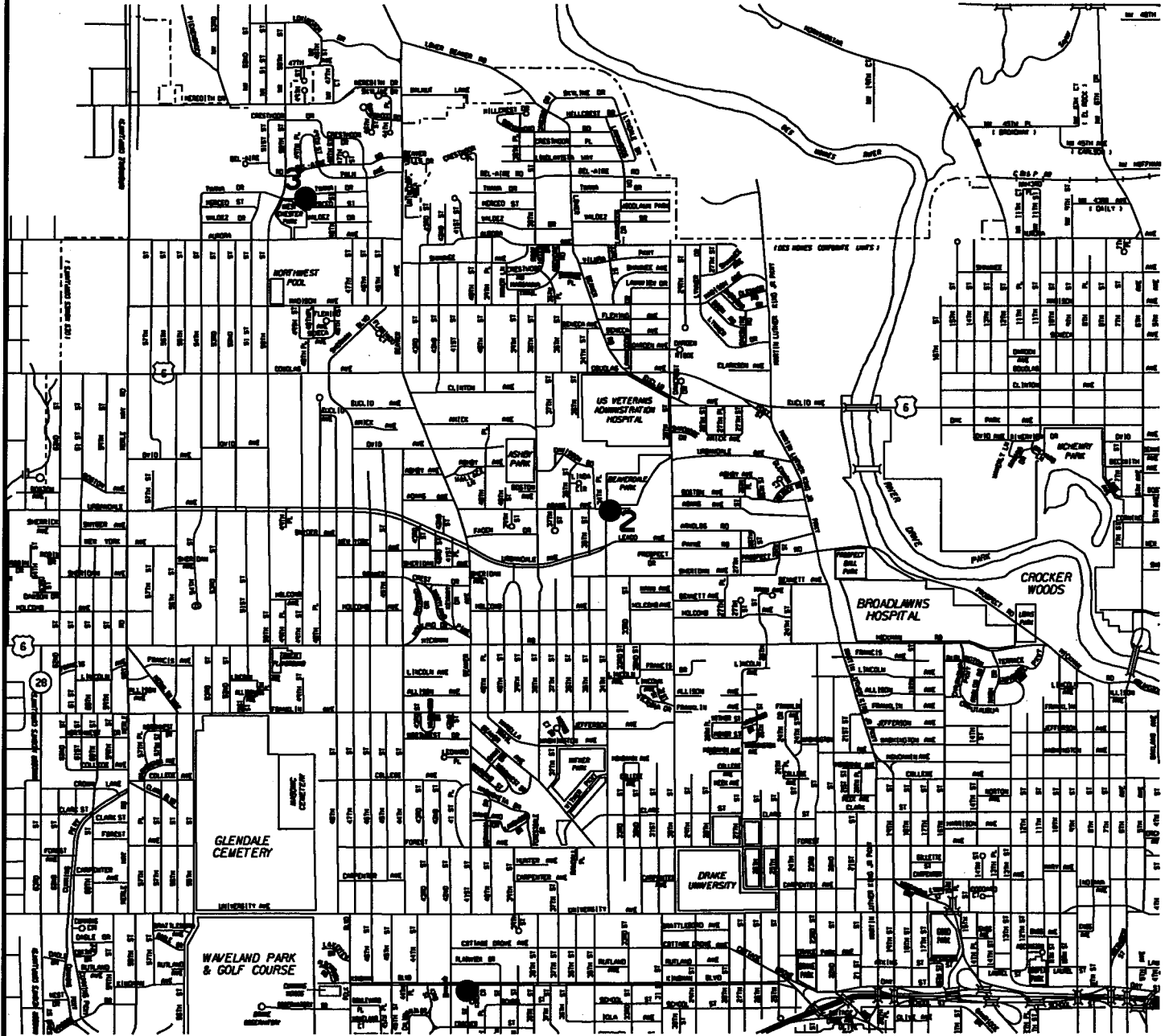

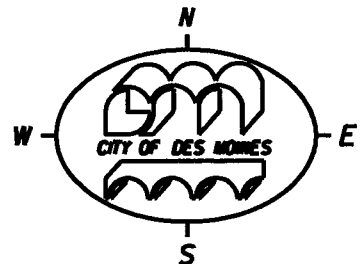

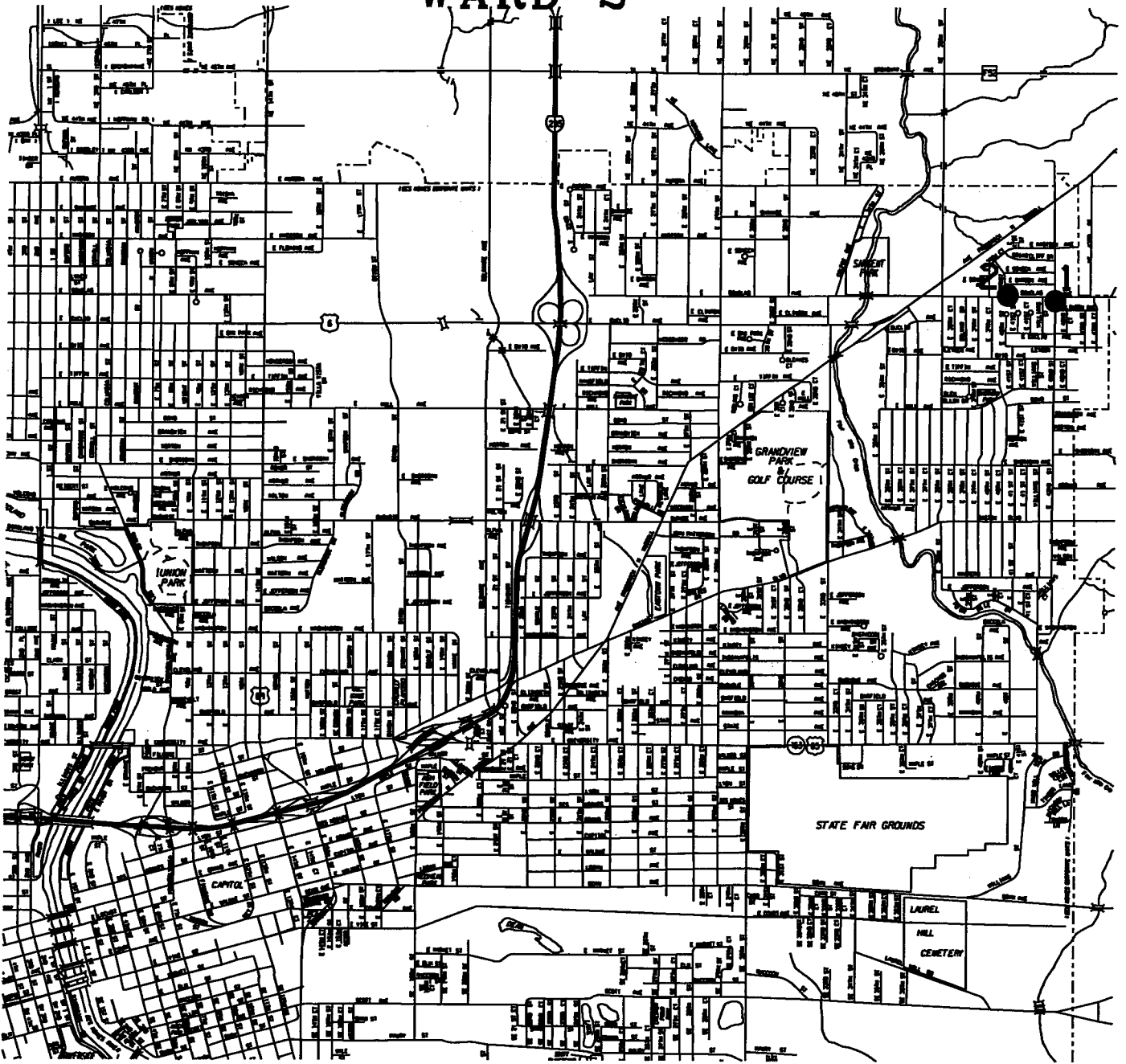
1. KINGMAN CIRCLE - KINGMAN BLVD. TO CUL-DE-SAC SOUTH

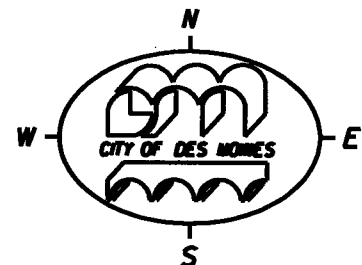

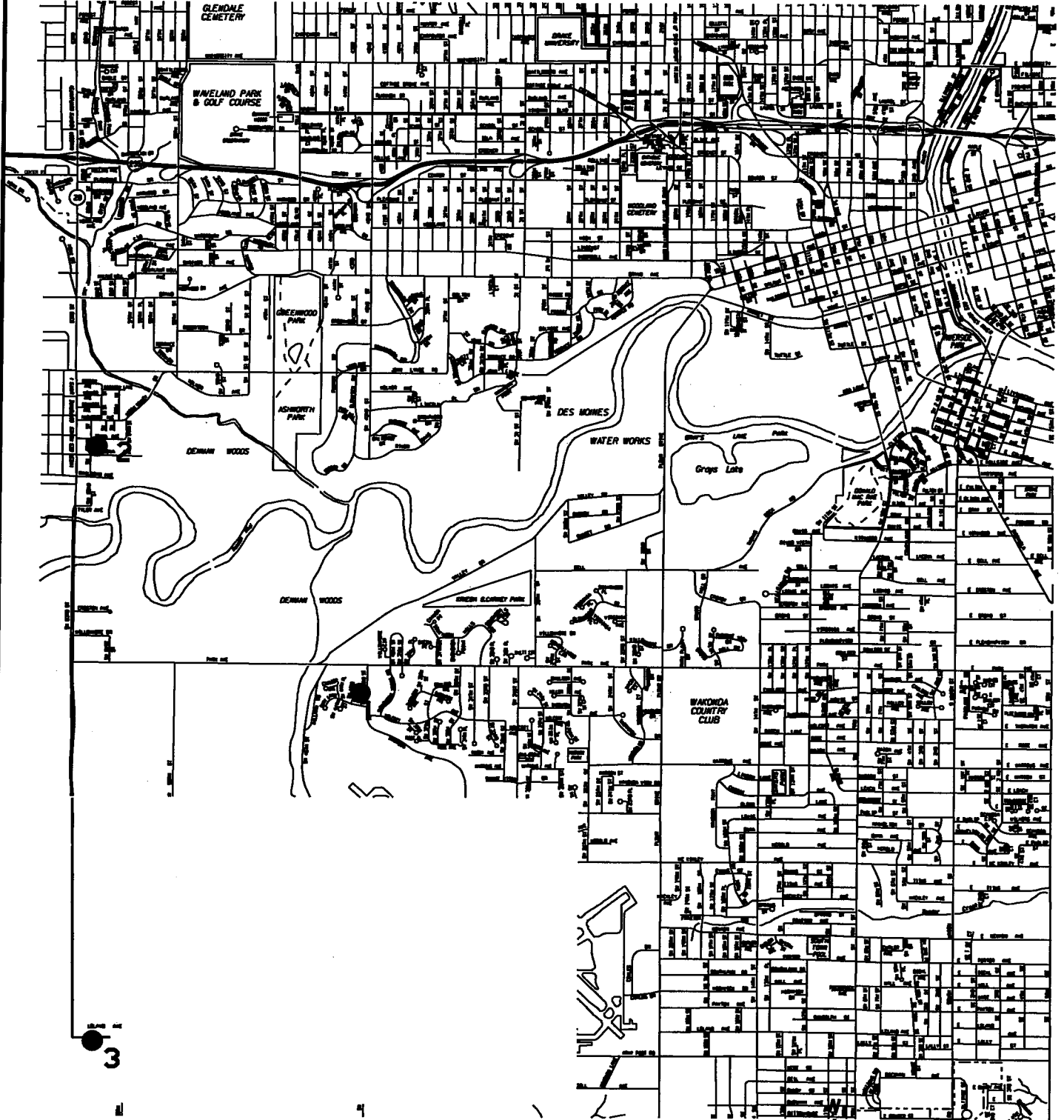

- 2. E. DOUGLAS AVENUE - E. 38TH ST. TO E. 42ND ST.

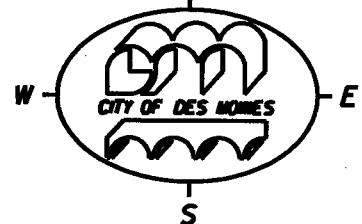

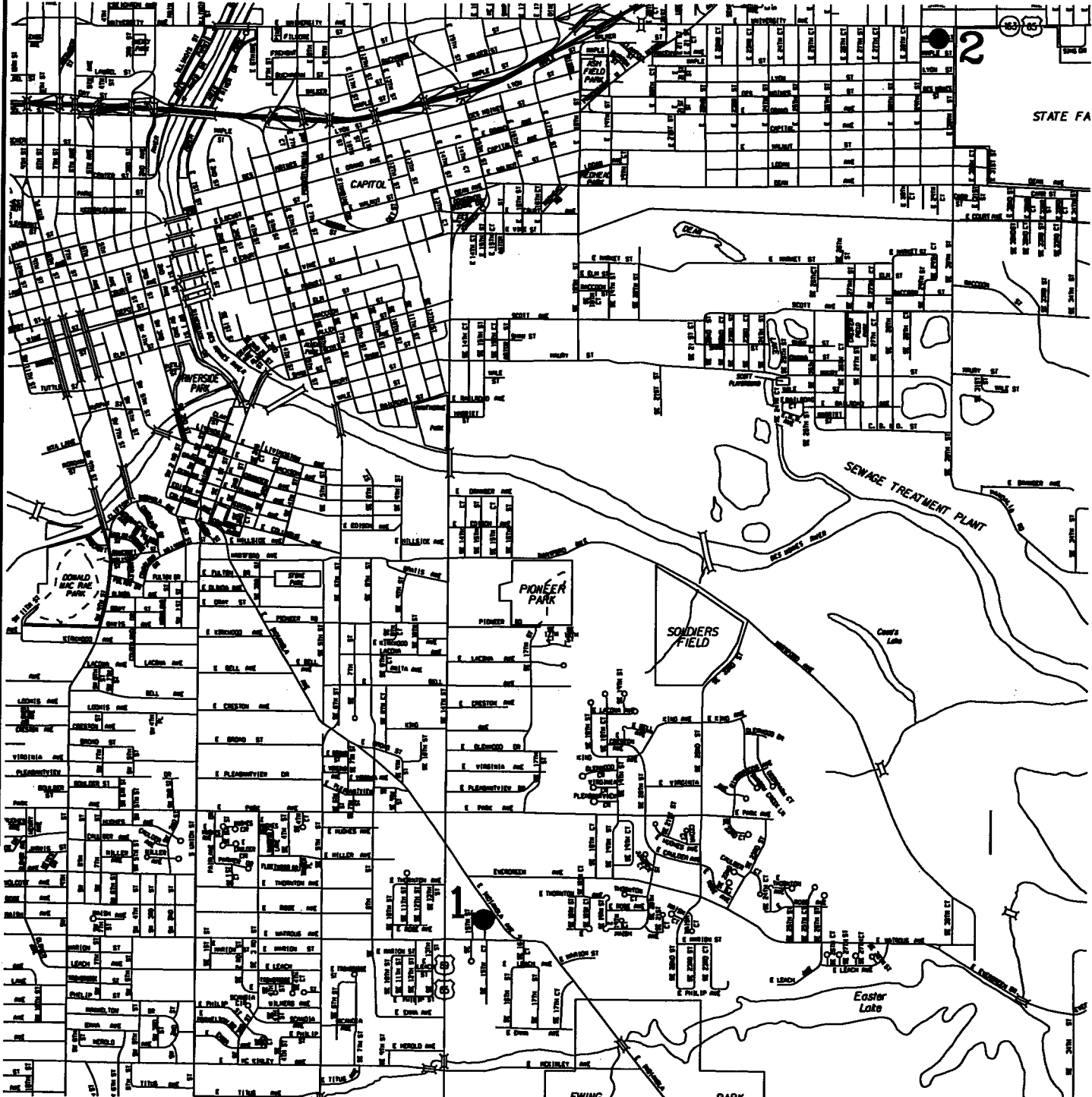
