AUTHORIZING AMENDMENTS TO EXTEND PRESENT  
CONTRACTS WITH THE ANIMAL RESCUE LEAGUE OF IOWA

WHEREAS, the City and the Animal Rescue League desire to amend to extend the Animal Control Shelter Lease and Services Agreement for the City of Des Moines Animal Shelter located at 1615 S.E. 14<sup>th</sup> Street, Des Moines, Iowa, wherein the current term is effective from August 1, 2008 and ends on July 31, 2011; and

WHEREAS, it is proposed to extend the lease and services agreement for the shelter to end on the City's fiscal year ending June 30, 2012; and

WHEREAS, the City and the Animal Rescue League also desire to extend the Animal Control Services Agreement, having a current term effective from March 23, 2009 and ending March 22, 2012, to end on the city's fiscal year ending June 30, 2012 whereby matching up the ending date with the ending date of the Animal Shelter Lease and Services Agreement; and

WHEREAS, approval of these contract amendments, now on file in the city clerk's office, to extend the end date to June 30, 2012 on both contracts is in the best interest of the City;

- A. Amendment to Animal Shelter Lease and Services Agreement, and
- B. Amendment to Animal Control Services Agreement.
