**RESOLUTION DESIGNATING PREFERRED REDEVELOPER
FOR THE PRIVATE REDEVELOPMENT OF THE DES MOINES BUILDING
AT 405 6th AVENUE AND 513 LOCUST STREET**

WHEREAS, on January 10, 2011, by Roll Call No. 0040, the City Council of the City of Des Moines declared the Des Moines Building at 405 6th Avenue and 513 Locust Street to be a public nuisance and authorized the Legal Department to pursue a court order for the abatement of such nuisance, and to pursue a court order declaring the building abandoned and awarding title to the City; and,

WHEREAS, on February 28, 2011, by Roll Call No. 11-0370, in anticipation that the City would be awarded title to the Des Moines Building, the City Council authorized and directed the City Manager to solicit proposals for the acquisition and private redevelopment of the Des Moines Building in accordance with the procedures and process identified in Council Communication No. 11-110; and,

WHEREAS, the City was awarded title to the Des Moines Building free and clear of all liens and encumbrances by an ordered entered by the Polk County District Court on May 26, 2011, in Case No. CD61147; and,

WHEREAS, the City has received two proposals for the redevelopment of the Des Moines Building, one from Nelson Development and Construction and Foutch Brothers, LLC (hereinafter referred to as "Nelson Foutch"), represented by Mike Nelson and Steve Foutch, and one from Sherman Associates, represented by George Sherman; and,

WHEREAS, the City Manager recommends that the City Council select the proposal submitted by Nelson Foutch as the preferred redevelopment proposal; designate Nelson Foutch or their designee, as the Preferred Redeveloper authorized to seek State of Iowa historic preservation tax credits, grayfields financial assistance and enterprise zone benefits, and for federal historic tax credits for the redevelopment of the Des Moines Building; and authorize the City Manager to negotiate a development agreement with Nelson Foutch or their designee for the redevelopment of the Des Moines Building upon terms consistent with its proposal for consideration by the City Council at a future date; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The redevelopment proposal submitted by Nelson Development and Construction and Foutch Brothers, LLC, is hereby approved as the preferred redevelopment proposal for the Des Moines Building.
2. Nelson Development and Construction and Foutch Brothers, LLC, or their designee, are hereby designated as the Preferred Redeveloper for the Des Moines Building. The designee

of Nelson Foutch must be a legal entity owned and controlled by Nelson Foutch and created solely for the purpose of rehabilitating the Des Moines Building.

- The City Council hereby declares its intent to consider selling the Des Moines Building more specifically described below, to Nelson Development and Construction and Foutch Brothers, LLC, or their designee, for a purchase price of \$150,000, and to provide 10-year 100% tax abatement or an equivalent economic incentive to Nelson Foutch or their designee for redevelopment of the Des Moines Building in a manner consistent with its proposal.

Lots Three (3) and Four (4) in Block C in Commissioner's Addition to Fort Des Moines, an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

- Nelson Development and Construction and Foutch Brothers, LLC, or their designee, are hereby authorized to make application for State of Iowa historic preservation tax credits, grayfields financial assistance and enterprise zone benefits, and for federal historic tax credits for the redevelopment of the Des Moines Building.
