Whereas, the policy outlined in the attached Council Communication provides an additional exemption to include a High Priority Sidewalk, which is based on multiple criteria; and

Whereas, the City Manager now recommends that the City Council consider adoption of the revised policy as outlined in the attached Council Communication.
