APPROVING SPONSORSHIP OF TAX CREDIT APPLICATION FOR RENOVATION OF THE YOUNKERS BUILDING

WHEREAS, by Roll Call No. 10-1782 of October 25, 2010, the City Council has given preliminary approval to an economic development grant to The Alexander Company, Inc. for the renovation of the Younkers Building at 713 Walnut Street and such renovation is to be funded, in part, with a State of Iowa Grayfield redevelopment tax credit; and

WHEREAS, the renovation of the Younkers Building is in the best interests of the City and the City desires to sponsor the tax credit application for the funding of such renovation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that, as established by the supporting documentation set out in the tax credit application, the Younkers Building property at 713 Walnut Street is designated as a grayfield property pursuant to the definitions set out in the application and Iowa Code Section 15.291.

BE IT FURTHER RESOLVED that the City hereby supports and sponsors the application for the State of Iowa Grayfield redevelopment tax credit for the funding of renovations at the Younkers Building and the City Manager or his designees are hereby authorized and directed to execute the application and all required documents and to provide all supporting information to indicate its support and sponsorship of the tax credit application.
