Community Development Department Neighborhood Revitalization Board Memorandum

Re:	2012 HUD Consolidated Plan Recommendations

At their meeting on Saturday, August 27, 2011, the Neighborhood Revitalization Board (NRB) adopted the attached funding recommendations for the 2012 HUD Consolidated Plan. The Plan includes the Community Development Block Grant (CDBG), Home Investment Partnerships (HOME) and the Emergency Shelter Grant (ESG) Programs.

The recommended allocations are based on community development objectives, which are included in the 5-year (2010–2014) HUD Consolidated Plan recommended by the NRB and adopted by the City Council on June 22, 2009. This was in conformance with a procedure recommended by the NRB and approved by the City Council, to allocate Consolidated Plan funds on a two-year basis.

On August 3, 2011, the NRB received the following estimate of HUD Consolidated Plan funding to be available in 2012: \$3,382,597 in CDBG; \$835,742 in HOME, and \$148,770 in ESG. After deducting for planning, management, indirect costs, citizen participation, and monitoring, there is \$3,607,016 available for projects (\$2,706,078) CDBG, \$752,168 HOME, and \$148,770 ESG).

The NRB recommendations take into consideration the City-Wide Strategic Plan, the Neighborhood Revitalization Plans, the 12 City Council Goal Statements, and the goals of the CDBG, HOME, and ESG programs which, are "to primarily benefit low- and moderate- income persons by providing decent housing; a suitable living environment; and expanding economic opportunities".

Most of the projects were funded at approximately the same level as last year, but in order to meet the 2012 budget projections, the NRB had to allocate less than what was requested by most agencies.

Based on performance reports and information provided by the agencies in their presentations to the NRB on August 22, 23, and 24, 2011 we have the following comments.

- Neighborhood Based Service Delivery the NRB's recommendation is a \$366,184 decrease from the 2011 allocation but takes into account the potential program income of \$115,000 from the salvage of abandoned vehicles.
- Economic Development Programs our recommendation of \$75,000 for both the Neighborhood Commercial Revitalization and Economic Development Programs is the same as the amount the agency received in 2011 and has not spent to date. There is also the potential program income received from loan repayments and other unspent funds from previous years.

- Homeless Programs the NRB recommendations for CDBG funding for Homeless assistance and other non-profit agencies is in compliance with the City Council's Actions on December 21, 2009 by Roll Call No. 09-2324 to reduce CDBG funding to non-profit agencies over a period of three years. The Board also voted to table the allocation of HEARTH Act and Emergency Solutions Grant funding until the final federal regulations are published. There is not enough known at this time to determine eligible activities and administrative procedures under these programs.
- Demolition The NRB is recommending that funding be increased for this program to support a more targeted approach to physically reducing slum and blight conditions in designated neighborhoods where abandoned and/or derelict properties is a problem. The NRB reduced funding to the NBSD program to provide additional funding to Demolition.

If there are additional 2012 CDBG, HOME, and/or ESG funds allocated by the federal government the NRB recommends that only agencies who applied for the 2012/2013 program years be considered for additional or reprogrammed funds. This insures that agencies do not by-pass the established citizen participation process and that their proposals have been reviewed. Also, the NRB asks the City Council to obtain input from the NRB if the 2012 allocation from HUD is more or less than the projected amount that was used in the 8/27/11 deliberations.

The NRB looks forward to working with city staff, other public/private agencies, and the City Council to implement the 2012 Consolidated Plan.
