**RESOLUTION APPROVING AMENDMENTS TO THE
SCHEDULE OF FEES AND SCHEDULE OF ADMINISTRATIVE PENALTIES
FOR THE NEIGHBORHOOD INSPECTION RENTAL CODE**

WHEREAS, the Neighborhood Inspection Rental Code Codified in Article of Chapter 60 Housing, in the Des Moines City Code, provides for the collection of fees and penalties in the amounts set in the Schedule of Fees and Schedule of Administrative Penalties adopted by the City Council by resolution; and,

WHEREAS, there is pending before the City Council a proposal to amend the Neighborhood Inspection Rental Code to provide for the collection of a research fee, for the research activities conducted and associated with the enforcement of such code; and,

WHEREAS, Article I of Chapter 60-55(a)(b) as so amended, provides for the collection of a research fee in the amount set by the City Council by resolution; and

WHEREAS, the City Manager recommends that the Schedule of Fees applicable to the Neighborhood Inspection Rental Code be amended as set forth in the accompanying schedules;
NOW THEREFORE

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

The adopted Schedule of Fees for the City of Des Moines is hereby amended by amendment of the fees imposed pursuant to the Neighborhood Inspection Rental Code, to be as set forth in the accompanying schedules, effective upon the passage and publication of the pending ordinance amending such code.
