AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-3256, 114-3694 and 114-4012, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-3256, 114-3694 and 114-4012 relating to traffic and vehicle regulations, as follows:

Sec. 114-3256. Grand Avenue--Thirteenth Street to Fifteenth Street.

Grand Avenue, on the south side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Grand Avenue, on the south side, from a point 20 feet west of Thirteenth Street to a point 260 feet west thereof, resident permit parking.

Grand Avenue, on the north side, from Fourteenth Street to a point 45 feet east thereof, no parking any time.

Grand Avenue, on the north side, from Fourteenth Street to a point 10 feet west thereof, no parking anytime.

Grand Avenue, on the north side, from Fourteenth Street to a point—85\_98 feet east of Fifteenth Street, no parking 4:00 p.m. to 6:00 p.m.

Grand Avenue, on the north side, from a point <u>225</u> <u>245</u> feet <u>east west</u> of Fourteenth Street to a point <u>35</u> <u>98</u> feet east thereof, no parking any time.

Grand Avenue, on the north side, from Fifteenth Street to a

point-85 96 feet east thereof, no parking any time.

Grand Avenue, on the south side, from Fifteenth Street to a point 33 feet east thereof, no parking any time.

Sec. 114-3694. University Avenue--Polk Boulevard to Sixty-third Street.

University Avenue, on the south side, from Polk Boulevard to a point 165 feet west thereof, two-hour parking 9:00 a.m. to 4:00

p.m.

University Avenue, on the south side, from a point 125 feet west of Polk Boulevard to a point ten 25 feet west thereof, is designated a shandicapped parking spaces and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

University Avenue, on the south side, from a point 165 feet west of Polk Boulevard to the entrance of Waveland Golf Course, no

parking any time.

University Avenue, on the north side, from Forty-eighth Street

to a point 50 feet west thereof, no parking any time.

University Avenue, on the north side, from a point 50 feet west of Forty-eighth Street to a point 550 feet west thereof, no parking 4:00 p.m. to 6:00 p.m.

University Avenue, on the north side, from Polk Boulevard to

Forty-eighth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

University Avenue, to the north side, from a point 50 feet west of Forty-eighth Street to a point 550 feet west thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

University Avenue, on both sides, from the entrance to Waveland Golf Course to Sixty-third Street, no parking any time.

Sec. 114-4012. Grand Avenue--Thirteenth Street to Fifteenth Street.

Grand Avenue, on the south side, from a point 20 feet west of Thirteenth Street to a point 33 feet west of Fifteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Grand Avenue, on the north side, from a point ten feet west of Fourteenth Street to a point 235 feet west thereof, four-hour

meters, 8:00 a.m. to 4:00 p.m.

Grand Avenue, on the north side, from a point 98 feet east of Fifteenth Street to a point 22 feet east thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
