**APPROVAL OF THE 2011 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CONTINUUM OF CARE PROGRAM APPLICATION**

WHEREAS, in response to a Notice OF Funding Availability (NOFA) for Homeless Assistance Grants published in the Federal Register on August 26, 2011, to supplement funding for local homeless programs, the City's Community Development Department in collaboration with the Continuum of Care Committee of the Polk County Housing Continuum Board prepared a SHP application for \$2,965,431 in Supportive Housing Program and Shelter Plus Care funds, which application is on file in the City Clerk's Office and by this reference made a part hereof, to be submitted to HUD for funding approval; and

WHEREAS, at their meeting on September 27, 2011, the Homeless Coordinating Council (HCC) received and recommended approval of the Polk County Housing Continuum Board's recommendations for the 2011 Supportive Housing Program (SHP) application, which were prepared by the Continuum of Care Committee and approved by the Polk County Housing Continuum Board at their meeting on September 21, 2011; and

WHEREAS, the application is based upon the City's Continuum of Care strategy, whereby Continuum of Care funds would provide needed services to homeless persons in Des Moines and throughout Polk County and address high priority service gaps within the parameters of the priorities and procedures recommended by the PCHC and the HCC Boards and adopted by the City Council.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above referenced Continuum of Care program application and certifications thereto are hereby approved and ratified, and the City Manager or his designee is hereby directed to execute any necessary documents and submit the application to HUD.
