## RESOLUTION APPROVING AMENDMENTS TO THE CITY PRECINCT AND . WARD BOUNDARIES AND APPROVING AMENDED AGREEMENTS WITH POLK COUNTY FOR COMBINED PRECINCTS

WHEREAS, the voting precincts of the City of Des Moines were established by Ordinance No. 15,051 passed September 26, 2011, as amended by Ordinance No. 15,053 passed October 10, 2011; and,

WHEREAS, the Iowa Director of Elections has conditionally approved the revised Polk County redistricting plan, subject to amendments being made to several of the combined city/township precincts that Polk County shares with the City of Des Moines; and,

WHEREAS, Polk County has requested that the City of Des Moines agree to amendments to Des Moines Precincts 7, 7A, 29 and 29A to satisfy the conditions imposed by the Iowa Director of Elections on the approval of the Polk County redistricting plan; and,

WHEREAS, the proposed new Des Moines Precincts 7, 29 and 29A are combined city/township precincts which can only be established pursuant to a written agreement between the City and Polk County.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The proposed amendments to Des Moines Precincts 7, 7A, 29 and 29A are hereby approved, subject final passage of the necessary ordinance.
- 2. The proposed Amended Memorandum of Agreement with Polk County authorizing the creation of Des Moines Precincts 7, 29 and 29A as combined city/township precincts is hereby approved.






