AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended by repealing Sections 1.7, 1.7A, 1.29, 1.29A and 2.2 of Appendix B, Election Precincts and Wards thereof, and enacting new Sections 1.7, 1.29, 1.9A and 2.2 to Appendix B, Election Precincts and Wards, regarding the precinct and ward boundaries.

BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as amended by Ordinance No. 13,986, passed August 20, 2001, by Ordinance No. 14,014 passed November 5, 2001, by Ordinance No. 15,051 passed September 26, 2011, and by Ordinance No. 15,053 passed October 10, 2011, be and is hereby amended by repealing Sections 1.7, 1.7A, 1.29 and 1.29A of Appendix B, Election Precincts and Wards thereof, and enacting a new Sections 1.7 and 1.29 to Appendix B, Election Precincts and Wards, regarding the precinct boundaries as follows:

APPENDIX B ELECTION PRECINCTS AND WARDS
Subchapter 1. Precincts

Sec. 1.7. Precinct 7, a combined City/Township Precinct.

Beginning at the intersection of the Des Moines River and the north corporate limits of the City of Des Moines; thence east, northeasterly, south, east, southeasterly, west, and south along said north corporate limits, an irregular line, to the westerly extension of Aurora Avenue; thence east along the westerly extension of Aurora Avenue and along Aurora Avenue to NW 9th Street; thence north along NW 9th Street to NW 43rd Avenue; thence east along NW 43rd Avenue to NW 6th Drive; thence south along NW 6th Drive and continuing straight south along vacated NW 6th Drive to Aurora Avenue; thence east along Aurora Avenue to Fifth Avenue; thence south along Fifth Avenue to Euclid Avenue (U.S. Highway 6); thence west along Euclid Avenue (U.S. Highway 6) to the Des Moines River; thence northerly along the Des Moines River to its intersection with the north corporate limits of the City of Des Moines, the point of beginning.

~~**Sec. 1.7A. Polk County Precinct Saylor 1, a combined City/Township Precinct also known as Des Moines Precinct 7A.**~~

~~Beginning at the intersection of NW 70th Avenue and NW 2nd Street (Iowa Highway 415); thence west along NW 70th Avenue and continuing west along the north line of Saylor Township to the center channel of the Des Moines River; thence south along the center~~

~~channel of the Des Moines River to the corporate limits of the City of Des Moines; thence easterly along the corporate limits of the City of Des Moines, an irregular line, to the point at which it converges with Aurora Avenue; thence east along Aurora Avenue and East Aurora Avenue to NE 8th Street; thence north along NE 8th Street to NE 44th Avenue; thence west along NE 44th Avenue to NE 7th Street; thence north along NE 7th Street to the NE 47th Place; thence westerly along NE 47th Place to NE 3rd Street; thence north along the NE 3rd Street to NE 48th Place; thence west along NE 48th Place to NW 2nd Street (Iowa Highway 415); thence north along NW 2nd Street (Iowa Highway 415) to the point of beginning.~~

Sec. 1.29. Precinct 29, a combined City/Township Precinct.

Beginning at the intersection of East Forty-Second Street and East Douglas Avenue; thence east along East Douglas Avenue to the corporate limits of the City of Des Moines; thence following said corporate limits generally easterly and northerly along an irregular line to Northeast Fifty-Sixth Street; thence north along Northeast Fifty-Sixth Street to Highway US 65; thence southeast along Highway US 65 to Northeast Twenty-Seventh Avenue (East Sheridan Avenue); thence west and northwest along Northeast Twenty-Seventh Avenue (East Sheridan Avenue) to Northeast Fifty-Sixth Street and the corporate limits of the City of Des Moines, Iowa; thence generally westerly along the corporate limits of the City of Des Moines as shown by the 2010 Decennial Census (an irregular line) to the intersection of NE 23rd Avenue (Easton Blvd) and NE 45th Court; thence continuing west along NE 23rd Avenue (Easton Blvd) to NE 44th Court; thence northerly along NE 44th Court to East Sheridan Avenue; -intersection of the west line of Delaware Township and East Sheridan Avenue; thence west along East Sheridan Avenue to East Forty-Second Street; thence north along East Forty-Second Street to its intersection with East Douglas Avenue, the point of beginning.

Sec. 1.29A. Polk County Precinct Delaware-2, a combined City/Township Precinct also known as Des Moines Precinct 29A.

Beginning at the intersection of Northeast Fifty-Sixth Street and the corporate limits of the City of Pleasant Hill, Iowa; thence generally westerly along said corporate limits of the City of Pleasant Hill to a point where the east corporate limits of the City of Des Moines meet the corporate limits of the City of Pleasant Hill; thence generally north and west-east along the easterly corporate limits of the City of Des Moines to NE Sheridan Avenue; thence east along NE Sheridan Avenue to NE 44th Court; thence southeasterly and south along NE 44th Court to NE 23rd Avenue (Easton Blvd); thence east along NE 23rd Avenue (Easton Blvd) to NE 45th Court; thence continuing easterly and northerly along the southerly corporate limits of the City of Des Moines as shown by the 2010 Decennial Census to Northeast Fifty-Sixth Street; thence south along Northeast Fifty-Sixth Street to the corporate limits of the City of Pleasant Hill, the point of beginning.

Subchapter 2. Wards


Sec. 2.2. Second ward described.

The second ward shall be and include those areas of the city encompassed by and located within the boundaries of precincts 1, 2, 3, 4, 5, 5A, 6, 7, ~~7A~~, 19, 20, 21, 22, 23, 24, 25,

26, 27, 28, 29, 29A, 30, and 33.

Sec. 2. This ordinance shall be in full force and effect from and after the later of its passage and publication as provided by law, or January 15, 2012.
