ACCEPTANCE OF REAL ESTATE DOCUMENTS FROM DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT FOR PROPERTY LOCATED AT 1323 EAST 25TH COURT AND SETTING HEARING FOR CONVEYANCE OF SAID PROPERTY TO DERRICK HUFFEY FOR \$6,000

WHEREAS, on January 24, 2011 by Roll Call No. 11-0138, the City of Des Moines approved an amendment to the First (2010) Year Action Plan of the 2010-2014 U.S. Department of Housing and Urban Development (HUD) Consolidated Plan; and

WHEREAS, the City has previously provided Community Development Block Grant (CDBG) funds from the above-mentioned Consolidated Plan to the Des Moines Independent Community School District for the East Side Remodeling Program, however said Program was combined with a Central Campus program and therefore eliminated by the School District in 2010; and

WHEREAS, the Des Moines Independent Community School District is the owner of real property locally known as 1323 East 25th Court, which had been included in the East Side Remodeling Program until the Program elimination; and

WHEREAS, Housing and Urban Development (HUD) requires said property be redeveloped for low-income housing due to the CDBG funding provided by the City of Des Moines through the HUD Consolidated Plan; and

WHEREAS, Des Moines Independent Community School District staff and City staff have negotiated terms whereby the real property locally known as 1323 East 25th Court will be conveyed at no cost by the School District to the City of Des Moines, and the City will transfer the property to a selected developer and administer redevelopment of the property through a development agreement; and

WHEREAS, on September 23, 2011, the City's Community Development staff distributed an RFP to developers certified with the City's Neighborhood Stabilization Program for redevelopment of the property located at 1323 East 25th Court, and the City's selection committee reviewed the received proposals and selected Derrick Huffey as the developer for the proposed housing project; and

WHEREAS, pursuant to the selected bid, Derrick Huffey has offered to the City of Des Moines the purchase price of \$6,000 for the purchase of the real property locally known as 1323 East 25th Court, more specifically described below, subject to restrictive covenants to ensure compliance with CDBG requirements for rehabilitated homes and for occupancy by a low- or moderate-income homebuyer; and

WHEREAS, to complete this development, the City must first accept the real property from the Des Moines Independent Community School District, and there is no known current or future public need for the real property proposed to be sold and the City will not be inconvenienced by the sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The attached documents conveying property interests, recommended for approval and acceptance by the Real Estate Division of the Engineering Department and by the Community Development Department, be and are hereby approved and accepted as follows:


