## SET HEARING FOR VACATION AND CONVEYANCE OF EXCESS RIGHT-OF-WAY LOCATED AT 3136 SW 9TH STREET TO PAUL A. & DONNA J. STEFFENSEN FOR \$5,000

WHEREAS, on April 8,1982, the City of Des Moines acquired real property locally known as 3136 SW 9<sup>th</sup> Street for right-of-way purposes for the widening of SW 9<sup>th</sup> Street and reconstruction of the intersection with Park Avenue; and

WHEREAS, on November 18, 1985, by Roll Call No. 5991, City Council adopted a recommendation from the City Plan and Zoning Commission determining that said right-of-way was remnant property following the City's widening and reconstruction project, and authorizing the right-of-way to be conveyed on a competitive bidding basis for a "C-1" zoning use; and

WHEREAS, said right-of-way was not conveyed following the 1985 resolution and it has again been determined by the City's Real Estate Division and other City departments that said property is no longer needed for City purposes; and

WHEREAS, Paul A. and Donna J. Steffensen are the owners of property locally known as 3138 SW 9<sup>th</sup> Street abutting said excess right-of-way, and have offered to the City of Des Moines the purchase price of \$5,000 plus closing fees of \$113 for the vacation and conveyance of such right-of-way, more specifically described below, which price reflects the restricted fair market value of the property subject to sideyard use and no-build restrictions as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating the excess right-of-way locally known as 3136 SW 9<sup>th</sup> Street, more specifically described as follows:
