That the Finance Director be and is hereby authorized to draw the checks listed on the check registers for the weeks of November 07 and November 14; to draw the checks for the bills of the Des Moines Municipal Housing Agency to be presented to the Finance Director for the weeks of November 07 and November 14; and to draw the checks for biweekly payroll due employees of the City on November 18th 2011.
