Information for Mayor, City Manager, and Council Members

Concerns with applicant(s): Tony Singh Dassan

Mr. Dassan is the owner of the property located at 727 SE 14th, Super Stop, and is applying for the liquor and cigarette permits there. Mr. Dassan also owns the properties of the University Groceries at 2121 University and 1621 University, and formerly held the licenses at both until the middle of this year.

Mr. Dassan was interviewed on 11-1-11 for the licenses at Super Stop. Mr. Dassan held the licenses at this location from 2004-2009. During this time his license was suspended 30 days for twice selling alcohol to underage informants. Mr. Dassan has fulfilled all his obligations with the State Alcoholic Beverage Division and City.

We discussed that the business had to be operated within the State laws and ordinances of the City. Mr. Dassan said he is planning to send his employees for training and have them sign a letter, that if they fail to check IDs and do their job correctly, they will be terminated. He was given a trespass letter to use to keep undesirable customers away and assist the police department in helping him do so. Mr. Dassan said he will work with the police department and have us walk through the store to make any suggestions to help him operate a successful business.

At this point the police department has signed off for approval of the licenses at Super Stop. We will continue to work with Mr. Dassan to try and make sure he operates within the law.

This information is for your consideration in the approval of Mr. Dassan's licenses.
