## ACCEPTING PROPOSAL FOR A CITY-WIDE BUSINESS ENTERPRISE SOFTWARE SYSTEM AND RELATED IMPLEMENTATION SERVICES FROM TYLER TECHNOLOGIES, INC. AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE A CONTRACT FOR THE PROVISION OF SAME

WHEREAS, on May 4, 2011, a Request for Proposals (RFP) for the acquisition of a new City-wide business enterprise software system and to assist in implementation of such new system, Enterprise Resource Planning System RFP V11-068, was issued by the Procurement Division of the Finance Department; and

WHEREAS, the Procurement Administrator solicited proposals by advertising and mailing RFP V11-068 to thirty one potential proposers with 5 proposals received; and

WHEREAS, an Evaluation and Selection Committee has reviewed and evaluated the proposals and has recommended that a contract for such services be awarded to Tyler Technologies, Inc., Christopher Hepburn, President, 370 U.S. Route One, Falmouth, Maine, 04105; and

WHEREAS, the City Manager desires to negotiate a contract with Tyler Technologies, Inc. for such system and services.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The proposal for a City-wide business enterprise software system and to assist in implementation of such new system submitted by Tyler Technologies, Inc. is hereby accepted and approved.

2. The City Manager is hereby authorized to negotiate a contract with Tyler Technologies, Inc, as described in the attached Council Communication, and to submit such resulting contract to the City Council for approval and execution.
