## APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR PAVING IMPROVEMENTS, IN E. 12TH STREET AT CATTELL ELEMENTARY SCHOOL, BETWEEN JOINER CONSTRUCTION CO., INC. AND DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT


