RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE A DEVELOPMENT AGREEMENT WITH HATCH DEVELOPMENT GROUP TO REDEVELOP THE SOUTHERN MEADOWS SITE AT 2800 SE 8TH STREET, DES MOINES, IOWA 50315

WHEREAS, the State of Iowa submitted a plan to HUD which proposed the allocation of \$4.2 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa to outline how to use these funds; and,

WHEREAS, the State of Iowa approved the City's plan to use the funds; and,

WHEREAS, the City has identified the Southern Meadows Apartments at 2800 SE 8th St. as a large-scale project that could benefit from the use of these funds; and,

WHEREAS, on September 13, 2010 by Roll Call 10-1476, the City hired Confluence to prepare a redevelopment plan for the properties; and,

WHEREAS, on November 21, 2011, by Roll Call 11-2003, the City Council of the City of Des Moines approved the first reading of the rezoning ordinance to rezone the site from Limited R-3 Multiple Family Residential and R1-60 Low Density Single Family Residential to "PUD" Planned Unit Development to implement the redevelopment plan; and,

WHEREAS, on September 12, 2011, by Roll Call 11-1582, the City Council of the City of Des Moines approved the competitive request for proposals as a method to dispose of the property; and,

WHEREAS, three proposals were submitted by interested developers to redevelop the site; and,

WHEREAS, a staff review committee scored all three proposals and scored the proposal from Hatch Development Group the highest.
