SET HEARING FOR CONVEYANCE OF CITY-OWNED PROPERTY LOCATED AT 1443 12TH STREET AND 1529 13TH STREET TO GREATER DES MOINES HABITAT FOR HUMANITY, INC. FOR \$13,500

WHEREAS, on August 10, 2009, by Roll Call No. 09-1431, the City Council of the City of Des Moines approved the acquisition of real property locally known as 1443 12th Street and 1529 13th Street, more specifically described below, and found that the while such acquisition was consistent with and advanced the Forest Avenue Urban Renewal Plan, it was not undertaken in the exercise of the City's urban renewal powers under Iowa Code Chapter 403; and

WHEREAS, Greater Des Moines Habitat for Humanity, Inc. has offered to the City of Des Moines the total purchase price of \$13,500 for the purchase of such City-owned properties, which price reflects the fair market value of the properties as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the property proposed to be sold and the City will not be inconvenienced by the sale of said property.

1. The City of Des Moines, Iowa proposes to convey properties locally known as 1443 12th Street and 1529 13th Street, and legally described below, to Greater Des Moines Habitat for Humanity, Inc. for the Forest Avenue Urban Renewal Project:

The South 18 feet of Lot 8 Summit Ridge Addition to North Des Moines and Lot 23 Block A of Albert Kryshers Addition to North Des Moines, Official Plats, all now included in and forming a part of the City of Des Moines, Polk County, Iowa. (locally known as 1443 12th Street); and

Lot 15 IDA A Shaws Sub Division, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa (locally known as 1529 13th Street)

2. The meeting of the City Council at which conveyance of such real estate is to be considered shall be on February 27, 2012, said meeting to be held at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above described proposal and any other(s) submitted prior to or during the public hearing.


