

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DES MOINES, IOWA:


Section 1. That this Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 27th day of February, 2012, for the purpose of taking action on the matter of the issuance of not to exceed \$880,000 General Obligation Bonds, the proceeds of which Bonds will be used to provide funds to pay costs of the improvement, repair and remodeling of municipal buildings, including Police Facility and Public Works Building improvements; and the construction, repair, and improvement of community centers, wading pools, swimming pools and aquatic centers, and shall bear interest at a rate not exceeding the maximum specified in the attached notice.
