AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-601, 114-2603, 114-2604, 114-2737, 114-2900, 114-3129, 114-3256, 114-3343, 114-3365, 114-3865 and 114-3866, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-601, 114-2603, 114-2604, 114-2737, 114-2900, 114-3129, 114-3256, 114-3343, 114-3365, 114-3865 and 114-3866, relating to traffic and vehicle regulations, as follows:

Sec. 114-601. Parking prohibited during certain hours.

- (a) When signs are erected giving notice thereof, no person shall park a vehicle between the hours specified in this section on any day at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction:
 - (1) No parking 7:00 a.m. to 6:00 p.m.
 - (2) No parking 4:00 p.m. to 9:00 a.m.
 - (3) No parking 10:00 p.m. to 7:00 a.m.
 - (4) No parking 7:00 a.m. to 4:00 p.m.
 - (5) No parking 7:00 a.m. to 5:00 p.m.
 - (6) No parking 8:00 a.m. to 5:00 p.m.(7) No parking 4:00 p.m. to 9:00 a.m.
 - (7) No parking 4:00 p.m. to 9:00 a.m. (8) No parking 10:00 p.m. to 6:00 a.m.
 - (9) No parking 6:00 p.m. to 6:00 a.m.
- (b) A person who violates any provision of this section shall pay a fine of \$30.00.
