The City of Des Moines is proposing to cut the Fire Department budget by \$608,000. This will be done by taking one medic unit out of service from our neighborhood Fire Station #6 and reducing fire department employees.

No matter how the City tries to spin this budget issue, the citizens of this area have already seen a reduction in services and response times. Future cuts to the Fire Department will only further increase these problems. This equates into a significant safety issue for our area senior citizens and, in fact, all of our area residents, businesses and schools.
