Brookside Drive, Grimes, Iowa, 50111, to complete said contract, pursuant to the terms of the Takeover Agreement appended hereto and by this reference made a part hereof; and

WHEREAS, this City Council has been advised and does believe that it would be in the best interest of the City of Des Moines to enter into said Takeover Agreement with Merchants Bonding Company (Mutual).
