

On December 5, 2011, under Roll Call No. 11-2088, the City Council awarded a contract to ESA, Inc., D. Mike Mitchell, President, 116 Gateway Drive, N. Sioux City, SD 57049 for the construction of the following improvement:

Asbestos Removal at Southern Meadows Phase 2, 2800 SE 8th, 25-2012-012

The improvement includes removal of asbestos containing materials including caulk, stair-tread, stair-tread adhesive, gray tar, black tar, built-up-roof, flooring, and flooring adhesive; all in accordance with the contract documents, prior to the demolition of Southern Meadows Apartments, 2800 S.E. 8th Street, Des Moines, Iowa

I hereby certify that the construction of said Asbestos Removal at Southern Meadows Phase 2, 2800 SE 8th, Activity ID 25-2012-012, has been completed in substantial compliance with the terms of said contract, and I hereby recommend that the work be accepted.
