APPROVING AGREEMENT WITH THE OMEGA GROUP FOR THE PROVISION OF CRIME VIEW SOFTWARE, PROFESSIONAL SERVICES, HOSTING SERVICES, TECHNICAL SUPPORT AND MAINTENANCE SERVICES AND AUTHORIZING CITY MANAGER TO EXECUTE SAME IN THE AMOUNT NOT TO EXCEED \$50,948

WHEREAS, on October 24, 2011, by Roll Call No. 11-1808, the City Council approved the procurement of a software upgrade and annual maintenance and support services from The Omega Group for Crime View Dashboard software used for crime analysis to develop crime patterns and trends; and

WHEREAS, such upgrade also included the procurement of hosting services for the related Crimemapping.com software, included within the \$50,948; and

WHEREAS, The Omega Group and City staff have negotiated a Professional Services Agreement covering licensing of the Crime View Dashboard software, professional services, hosting services for Crimemapping.com, technical support, and annual maintenance services, a copy of which is on file in the City Clerk's Office; and

WHEREAS, such Agreement provides for annual maintenance and technical support services after the initial year following completion of installation of the Crime View Dashboard software in the amount of \$6000.00, subject to a 3% annual increase; and

WHEREAS, the Police Chief and Information Technology Director recommend approval of such Agreement.

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of Des Moines, Iowa, that the above described Professional Services Agreement for Crime View software, professional services, hosting services, technical support and annual maintenance services, a copy of which is on file in the City Clerk's Office, is hereby approved and the Chief of Police is hereby authorized and directed to execute such Agreement with The Omega Group in an amount not to exceed \$50,948, plus additional annual amounts for maintenance services, on behalf of the City, and the City Clerk is directed to attest to her signature.
