HOLD HEARING FOR CONVEYANCE OF THE PORTION OF VACATED NORTH/SOUTH ALLEY RIGHT-OF-WAY NORTH OF SCOTT AVENUE BETWEEN SE 6TH AND SE 7TH STREETS ADJOINING 506 SE 7TH STREET TO JEANNE M. WARE AND BES M. SANDBERG IN EXCHANGE FOR AN ACCESS RIGHTS DEED REQUIRED FOR THE SOUTHEAST CONNECTOR PROJECT

WHEREAS, on January 6, 1992, by Roll Call No. 92-035, the City Council passed Ordinance No. 11,762 vacating the north/south alley right-of-way north of Scott Avenue between SE 6th and SE 7th Streets; and

WHEREAS, on April 25, 2005, by Roll Call No. 05-969, the City Council authorized acquisition of the necessary right-of-way and easements for the Southeast Connector Project from SW 2nd Street to SE 14th Street; and

WHEREAS, the properties at 500 and 506 SE 7th Street, owned by Jeanne M. Ware and Bes M. Sandberg, had access to Allen Street that was eliminated due to the Southeast Connector Project; and

WHEREAS, the City Real Estate Division has acquired an Access Rights Deed from Jeanne M. Ware and Bes M. Sandberg acquiring all rights of direct access to their property from Allen Street as required by the Southeast Connector Project, with consideration being conveyance from the City of the adjoining vacated alley to provide comparable access to their property subject to restrictions on use and development of the parcel; and

WHEREAS, there is no known current or future public need or benefit for the vacated right-of-way proposed to be exchanged, and the City will not be inconvenienced by the conveyance of said property; and

WHEREAS, on March 12, 2012, by Roll Call No. 12-0384, it was duly resolved by the City Council that the proposed conveyance of such vacated right-of-way be set down for hearing on March 26, 2012, at 5:00 p.m., in the City Council Chambers; and


WHEREAS, due notice of said proposal to convey this public real property was given as provided by law, setting forth the time and place for hearing on said proposal; and
