The following is a report on the Fast Mart, formerly The Oasis, 1401 Buchanan, and was requested by the City Council.

On Wednesday, March 28, 2012, Lt. Jeff Edwards, commander of the Vice/Narcotics Control Section, Officer Bjornson, Vice Unit Compliance Officer, met with Khalid Khan, owner of the Fast Mart located at 1401 Buchanan. They discussed the outcome of the City Council meeting on March 26, 2012 and the impact this will have on his business. Mr. Khan has already discussed this with his attorney, Alfredo Parish, and is planning on an appeal with the Alcoholic Beverages Division to allow sales between April 7 and April 9, 2012.

The following is a list of things that the Fast Mart is currently doing to become a responsible business in the neighborhood:

- • The liquor aisle is roped off during school hours and no students are allowed down the aisle.
- • A sign is posted on the front door that does not allow more than five students in the business at a time. This is enforced by an employee that is currently working from 10-2 everyday specifically assigned as security.
- No tobacco sales to any students or friends of students regardless of age during school hours. Mr. Khan does not sell to young people even if they are legal to purchase if he believes they are buying for the purpose of giving tobacco products to minors.
- • Mr. Khan has "no trespassing/loitering" signs on all sides of his property, and assured us that he and his employees will monitor the area surrounding his store to ensure students and others are not loitering.
- • Mr. Khan has signed a current trespass letter giving us authorization for enforcement on the property when they contact us.
- • Mr. Khan's security employee makes regular checks on the sides and behind the business to eliminate loitering smoking (he states he does not allow smoking on his property).

Additionally, Mr. Khan has agreed to:

- • Eliminate the mobile taco vendor from his property.
- • Extend the hours of his security person to 10-2 Monday through Friday.
- • Add additional staff to allow 2 employees from 2pm until close every day.

Mr. Khan has hired police officers in the past to deal with complaints/problems but indicated that he cannot afford the expense of hiring a private security company or officers at this time. Mr. Khan was very cooperative and indicated that he would welcome and support any enforcement action on his property including using officers inside his business for undercover operations. He has cooperated in the past by volunteering to remove and discontinue sales of all synthetic substances at our request and has passed numerous compliance checks in the past year.

NCS will conduct a tobacco enforcement operation next week targeting illegal possession of tobacco next week on the Fast Mart property as well as the general area. Violators will be issued citations.

By eliminating the taco vendor from the property, we believe students will be less likely to order and eat food on the property, giving the appearance of large groups of loitering individuals. Smoking enforcement will also have an impact on underage smoking around the school. Both actions should provide relief to the appearance of these large groups of students.
