CONTINUE THE PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON TUTTLE STREET AT S.W. 8TH & S.W. 9TH STREETS TRAFFIC SIGNALS

WHEREAS, on March 12, 2012, under Roll Call No. 12-0376, the City Council of the City of Des Moines, Iowa approved a Resolution ordering construction, and fixing a date for receiving of bids on March 27, 2012, and April 9, 2012, as the date for public hearing on the plans, specifications, form of contract documents, and Engineer's estimate, for the construction of the following improvement:

Tuttle Street at S.W. 8th & S.W. 9th Streets Traffic Signals, 04-2009-010
CS-TSF-1945(740)--85-77

The improvement includes installation of traffic signals at the intersections of S.W. 8th and S.W. 9th Streets at Tuttle Street and other incidental items; all in accordance with the contract documents, including Plan File Nos. 531-28/38, located at the intersections of S.W. 8th and S.W. 9th Streets at Tuttle Street, Des Moines, Iowa

WHEREAS, the date for receiving of bids has been deferred from March 27, 2012 to April 10, 2012, resulting in the date for public hearing on the plans, specifications, form of contract, and Engineer's estimate to be deferred from April 9, 2012 to April 23, 2012; and

WHEREAS, such action to defer the dates for receiving of bids and public hearing shall be approved by this Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the public hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be changed from April 9, 2012 to April 23, 2012, to be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 5:00 p.m., at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That the aforesaid action is hereby approved, and the receiving of proposals by the City of Des Moines, at the office of the Des Moines City Clerk will be deferred from 11:00 a.m. on March 27, 2012 until 11:00 a.m. on April 10, 2012, for the construction of said improvement, and the taking of bids in the manner required by law, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its April 23, 2012 meeting.
