## RESOLUTION TO APPOINT A MEMBER AND AFFIRM THREE MEMBERS TO THE DES MOINES ENTERPRISE ZONE COMMISSION

WHEREAS, the Enterprise Zone program, as authorized by Iowa Code §§ 15E.191-97 (the "EZ Program") provides that certain eligible cities and counties may designate areas as enterprise zones and apply to the State of Iowa for enterprise zone certification to facilitate economic reinvestment in economically distressed areas; and

WHEREAS, the Iowa Economic Development Authority ("IEDA") Board of Directors has certified fourteen Enterprise Zones in the City of Des Moines and amendments thereto, including 13 contiguous acres in Pleasant Hill; and

WHEREAS, cities with State-certified enterprise zones are required to establish and maintain a nine member Enterprise Zone Commission ("Commission") to administer the EZ Program pursuant to Iowa Code §§15E.195(2); and

**WHEREAS**, appointments to the Commission must be made pursuant to Iowa Code § 15E.195(2) to continue the work of the Commission; and

**WHEREAS**, three members have been appointed by the Enterprise Zone Commission that are now submitted for City Council affirmation; and

WHEREAS, a member from Iowa Workforce Development has been submitted for appointment by City Council; and

WHEREAS, the appointments to the Enterprise Zone Commission shall be as follows:
