Hello:

You may remember me from last fall. A moratorium on closures of post offices helped keep the Capitol Square office open another five months. But the Moratorium will be lifted on May 15. I have asked Deb Woodrum if the Capitol Square office has been removed from the closure list or the date scheduled for closure. So far, no answer, at all!!!

So, on May 14, one day before the lifting of the moratorium, the National Federation of the Blind, the Postal Union and the Iowa Alliance of Retired Persons are planning a rally, once again. Much as it was in November. Our focus will be to get as many people to sign post cards to Postmaster Deb Woodrum, asking to keep this post office open.

Last fall, you and the city council let us use your name as supporters of the rally. I would ask you once again, if we can add your name, Mayor Cownie and the City Council of Des Moines to our flyer and press releases.

If we hear from Deb Woodrum before the event, but long after we have started to promote the event, that the post office is removed from the list of offices to be closed by that time, then it will become a celebration of sorts.

Dear Senator Grassley:

This responds to your recent letter on behalf of Des Moines City Manager Richard A. Clark, further referencing the Capitol Square and Highland Park Stations.

Thank you for sharing Mr. Clark's additional comments. I appreciate your continued interest in ensuring that all of your constituents continue to have convenient access to essential postal services.

We again contacted Hawkeve District postal officials who confirmed that after careful consideration, a final determination was made to close the Highland Park Station, effective October 21, 2011. Delivery and retail services are provided by the Des Moines Post Office, and Post Office box customers had the option of establishing carrier delivery or renting a Post Office box at the Des Moines Post Office. A final determination has also been made to close the Capitol Square Station; however, as you as you are aware, on December 13, 2011, the Postal Service announced a moratorium on the closing or consolidation of Post Offices and mail processing facilities until May 15. The Postal Service will continue all necessary steps required for the review of these facilities during the interim period, including public input meetings. The Postal Service hopes this period will help facilitate the enactment of comprehensive postal legislation. Given the Postal Service's financial situation and the loss of mail volume, we must continue to take all steps necessary to reduce costs and increase revenue.

With regard to Mr. Clark's concerns about access to postal facilities for persons with disabilities, I would note that there are currently 7 Post Offices and more than 60 retail outlets that sell postage stamps within a 5 mile radius of the Capitol Square Station. Customers may find these locations at our new website at www.uspseverywhere.com or by calling 1-800-ASK-USPS. In addition, customers can buy stamps online through our website at www.usps.com, by phone at 1-800-STAMP24, or by mail. Our Click-N-Ship service on www.usps.com enables customers to print shipping labels with postage for Express Mail and Priority Mail and request that the items be picked up via our Carrier Pickup program. Customers also can place their mail on hold, file a change-of-address order, or request the redelivery of an item for which a notice was left by calling 1-800-ASK-USPS or visiting www.usps.com. . . 1.14
