WHEREAS, on April 23, 2012, by Roll Call No. 12-0604, it was duly resolved by the City Council that the conveyance of such right-of-way be set down for hearing on May 7, 2012, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to convey vacated public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
