AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2631, 114-2633 and 114-3147, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2631, 114-2633 and 114-3147 relating to traffic and vehicle regulations, as follows:

Sec. 114-2631. Fifth Avenue--Locust Street to Grand Avenue.

Fifth Avenue, on the east side, from Locust Street to Grand Avenue, no parking any time.

Fifth Avenue, on the west side, from Locust Street to Grand Avenue, no parking any time. loading zone, 9:00 a.m. to 3:00 p.m. and 6:00 p.m. to 7:00 a.m.

Fifth Avenue, on the west side, from Locust Street to Grand Avenue, no parking 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 p.m.

Sec. 114-2633. Fifth Avenue--Watson Powell Jr Way to School Street.

Fifth Avenue, on the east side, from Watson Powell Jr Way to a point 20 feet north thereof, no parking any time.

Fifth Avenue, on the west side, from Watson Powell Jr Way to a point 55 feet north thereof, no parking any time.

Fifth Avenue, on the east side, from a point 130 feet north of Watson Powell Jr Way to a point 25 feet north thereof, commercial loading zone.

Fifth Avenue, on the west side, from Park Street to a point 20 feet north thereof, no parking any time.

Fifth Avenue, on the west side, from Center Street to a point 20 feet south thereof, no parking any time.

Fifth Avenue, on the east side, from Center Street to a point 40 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from Center Street to a point 50 feet north thereof, no parking any time.

Fifth Avenue, on the east side, from Crocker Street to School Street, no parking any time.

Sec. 114-3147. Des Moines Street--Robert D Ray Drive to East Ninth Street.

Des Moines Street, on the south side, from Robert D Ray Drive to a point 350 65 feet east thereof, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Des Moines Street, on the south side, from a point 65 feet east of Robert D Ray Drive to a point 80 feet east thereof, no parking any time.

Des Moines Street, on the south side, from a point 145 feet east of Robert D Ray Drive to a point 230 feet east thereof, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Des Moines Street, on the north side, from Robert D Ray Drive to Pennsylvania Avenue, no parking any time.

Des Moines Street, on the south side, from a point 50 feet west of East Fourth Street to a point 50 feet east of East Fourth Street, no parking any time.

Des Moines Street, on the south side, from a point 50 feet west of East Fifth Street to a point 50 feet east of East Fifth Street, no parking any time.

Des Moines Street, on the south side, from Pennsylvania Avenue

to East Ninth Street, no parking Monday through Saturday.

Des Moines Street, on the north side, from East Ninth Street to a point 50 feet west thereof, no parking any time.
