RESOLUTION DISMISSING PUBLIC HEARING FOR CONVEYANCE OF PROPERTY LOCATED AT 1202, 1204 AND 1300 SCOTT AVENUE TO MIDWEST AUTOMATIC FIRE SPRINKLER COMPANY FOR \$605,000

WHEREAS, on May 21, 2012, by Roll Call No. 12-0838, the public hearing on said proposal was continued to the June 11, 2012 Council meeting as requested by Midwest Automatic Fire Sprinkler Company; and

WHEREAS, on June 11, 2012, by Roll Call No. 12-0924, the public hearing on said proposal was further continued to the June 25, 2012 Council meeting upon request by Midwest Automatic Fire Sprinkler Company; and
