Dear Mayor Cownie and City Council Members:

I am writing on behalf of my client Midwest Networks Development, LLC ("MND") to express support for the above-referenced amended ordinance you will be considering today, July 23, 2012, and to urge you to:

- 1. Vote in favor of the proposed amendment to Chapter 102 of the Des Moines Municipal Code at its First reading today July 23, 2012, and
- 2. Agree to waive the rule requiring that an ordinance must be considered and voted on for passage at two Council meetings prior to the meeting at which it is to be finally passed and, instead, also vote for Final approval of the proposed amendment to Chapter 102 today, July 23, 2012.

Midwest Fiber Networks, LLC, headquartered in Wisconsin, provides fiber optic development and construction services itself, and through its affiliate MND. MND is currently working on a multi-state project to help improve the connectivity of one of its clients. As part of this project, MND began working with Des Moines city staff as early as February 2012 in an effort to obtain all the approvals necessary to complete a project to expand its fiber optic network through Des Moines. More than three-quarters of the project involves installation of fiber optic cable in Des Moines' overhead right-of-way on utility poles, with the remainder requiring

installation of the cables below ground. MND's goal was to have the Des Moines leg of the project completed by August 30, 2012. Although its application materials were submitted and seem to be in order, MND ultimately learned in mid-June that it was not eligible for the necessary license because its proposed use of the right-of-way was not contemplated by Des Moines City Ordinance section 102-763 which defines the "Persons eligible for issuance of a license."

Since then we have been in communication with Assistant City Attorney Glenna Frank regarding this matter. We appreciate her keeping us informed as to the progress of efforts to draft amendments to the ordinance that will give the City Engineer the authority to issue right-ofway licenses to entities such as MND, as well as to other entities that are not covered by the current terms of the ordinance.

We understand that the standard procedure for approving amendments to an ordinance is that the ordinance will be considered at one City Council meeting and, if approved, must then be considered and approved at a successive City Council meeting. In this instance, if the amended ordinance is approved at the July 23, 2012 City Council meeting, it would then have to be considered at the August 13, 2012 meeting. We understand that there is a procedural avenue that allows First and Final consideration of the amended ordinance at the same Council meeting, and have submitted a request to the Des Moines City Clerk, asking that the requirement for reading at a second Council meeting be waived in this instance. MND, which plans to employ local crews for the initial build out of the network, and also for the long-term maintenance of its facilities, is eager get this already-delayed project off the ground and to begin work in the City of Des Moines. It respectfully requests that if the proposed amendments to Chapter 102 are approved, the Final reading of the amended ordinance also take place at the City Council meeting on July 23, 2012 so that the terms of the ordinance can thereafter be implemented as soon as possible.
