BE IT RESOLVED (Choose one of the two alternatives):

Alternative One: That the order of the hearing officer be upheld and Mr. and Mrs. Dyer's two dogs be declared vicious.

Alternative Two: That the order of the hearing officer be reversed and Mr. and Mrs. Dyer's dogs not be declared vicious.

MOVED BY TO REVERSE DECLARATION.
