AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 74-184, relating to Brenton Skating Plaza ice rink fees.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 74-184 relating to Brenton Skating Plaza ice rink fees, as follows:

Sec. 74-184. Brenton Skating Plaza fees.

(a) Fees for use of the Brenton Skating Plaza ice rink shall be as follows:

(1) Ice rink admissions:

| c. | Freestyle (figure skating only) | \$ 7.00 <u>8.00</u> |
| d. | Family night (Thursdays) | \$ 8.50 <u>18.95</u> -(for family of four or more, <u>includes skates</u>) |
| e. | Season Pass – Adult | \$ 95.00 |
| f. | Season Pass – Child | \$ 60.00 |
| g. | Season Pass – Family | \$ 95.00 for the first two family members and \$35.00 for each additional member with a maximum fee of \$199.00 |
