RESOLUTION APPROVING HOME FUNDING AGREEMENT WITH HATCH DEVELOPMENT GROUP LLC FOR THE DEVELOMPENT OF 38 UNITS OF HOUSING AT 2800 SE 8TH STREET

WHEREAS, the State of Iowa submitted a plan to HUD which proposed the allocation of \$4.2 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa to outline how to use these funds; and,

WHEREAS, the State of Iowa approved the City's plan to use the funds; and,

WHEREAS, the City has identified the Southern Meadows Apartments at 2800 SE 8th St. as a large scale project that could benefit from the use of these funds; and,

WHEREAS, on September 13, 2010 by Roll Call 10-1476, the City hired Confluence to prepare a redevelopment plan for the properties; and,

WHEREAS, on January 23, 2012 the City Council of the City of Des Moines approved a development agreement with Hatch Development Group LLC for the development of 38 units of housing at the Southern Meadows site; and,

WHEREAS, Hatch Development Group LLC intends to transfer the property to Southern Meadows Homes LP for the construction of the project; and,

WHEREAS, Hatch Development Group LLC applied for a \$491,000 Home Investment Partnership's Program (HOME) Loan to assist with the costs to prepare the site for development; and,

WHEREAS, the loan agreement, a copy of which is on file in the Clerk's office, is structured as a non-receding lien on the property for a period of twenty years at which point the loan will be forgiven; and,
