The Dublin, 2307 University, Agreement

In the past under the previous liquor license, the Dublin bar located at 2307 University, was known for allowing/serving minors in the bar, noise complaints, and over-serving legal aged patrons. Law enforcement attempts to resolve the issues and work with staff was unsuccessful. As with every business in the City of Des Moines, we would like the Dublin to thrive and be successful but also be responsible and considerate of the other businesses and residents. The following is a plan to operate that will help to ensure the Dublin is successful and responsible while being a good neighbor to the residents, Drake University, and other businesses in the area:

- 1) Use electronic license readers whenever possible to screen customers to ensure persons under legal age are not allowed in the business.
- 2) Scrutinize ID's to ensure the customer is the one pictured and require additional ID if necessary.
- 3) When in doubt if the ID presented belongs to the person trying to gain entrance, deny them. It is better to turn a customer away than risk the liquor license.
- 4) Have problem patrons advised by police of criminal trespass and ban them from the bar.
- 5) Keep doors closed at all times to reduce noise complaints.
- 6) Self-monitor sound/bass levels outside the bar to ensure noise levels are not disruptive to others.
- 7) Move speakers/subs so noise is not directed toward residences.
- 8) Hold staff accountable for customers to prevent:
 - a. Over serving
 - b. Persons under legal age in the bar
- 9) Cooperate fully with law enforcement efforts/investigations.
- 10) Continue to work with the Des Moines Police Vice and Narcotics Office Liquor Coordinator, neighborhood residents, and Drake University to address any complaints, concerns, or questions.

The Des Moines Police Department Vice and Narcotics Control Section will continue to monitor the Dublin and to work with the business, Drake University, and other residents to ensure compliance with State Law and local ordinances. We will work with management and employees to ensure a safe venue for all patrons and to protect the rights of all other businesses and residents.
