RESOLUTION TO APPROVE SUBMISSION OF AN APPLICATION TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY FOR DIRECT FINANCIAL ASSISTANCE FOR MORTGAGE COMPLIANCE ADVISORS, LLC

WHEREAS, by Roll Call 12-0793, City of Des Moines approved a Des Moines Action Loan Fund Loan for \$100,000 to assist Mortgage Compliance Advisors, LLC ("Company"), a Salt Lake City, Utah based company to open a production center in the City of Des Moines; and
