APPROVING GRANT AGREEMENT WITH IOWA HOMELAND SECURITY AND ENERGY MANAGEMENT DIVISION (IHSEMD) AND IOWA DEPARTMENT OF ADMINISTRATIVE SERVICES (DAS) FOR CYBER RISK REDUCTION AND AUTHORIZING IT DIRECTOR TO EXECUTE IMPLEMENTING ADDENDUMS

WHEREAS, the U.S. Department of Homeland Security (DHS), allocated funds to states and local governments through the federal Homeland Security Grant Program for approved initiatives supporting national priorities and state strategies directed toward prevention, response, mitigation and recovery efforts related to terrorist attacks; and

WHEREAS, the DHS has awarded the State of Iowa a Cyber Risk Reduction grant in the amount of \$146,500.00 and Iowa Homeland Security and Emergency Management Division (IHSEMD) has prepared a Grant Agreement Between HSEMD and the City of Des Moines and the Iowa Department of Administrative Services (DAS) to perform work supporting Cyber Risk Reduction Phase 3 under the Initial Strategy Implementation Plan developed by IHSEMD, (Grant # EMW-2012-SS-00028-30), ("Grant Agreement"), on file in the Office of the City Clerk; and

WHEREAS, the Grant Agreement transfers primary responsibility for compliance with the grant terms to the DAS and DAS agrees to be responsible for implementation of the Grant.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines Iowa that the above described Grant Agreement, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is hereby authorized and directed to execute said Grant Agreement on behalf of the City.

BE IT FURTHER RESOLVED that the Information Technology Director is hereby authorized and directed to transfer such grant funds to the DAS in accordance with the Grant Agreement and to execute implementing addendums to the Grant Agreement, subject to approval as to form by the Legal Department.
