## APPROVING AND AUTHORIZING THE EXECUTION OF AMENDMENT TO NORFOLK SOUTHERN RAILWAY COMPANY CONSTRUCTION AND FLAGGING AGREEMENT FOR THE SOUTHEAST CONNECTOR PROJECT

WHEREAS, the Norfolk Southern Railway Company (NSR) owns and operates a railroad and operates the Burlington Northern Santa Fe (BNSF) railroad, both within the area near and adjacent to the Southeast Connector Project; and

WHEREAS, the Southeast Connector includes construction of roadway improvements adjacent and over the NSR rail lines; and

WHEREAS, NSR has certain requirements that must be satisfied to allow construction on or near the railroad; and

WHEREAS, as provided in the construction and flagging agreement, the NSR will provide the necessary switch tenders, flagmen, watchman and other protective services and devices to promote safety and insure continuity of train operations as may be necessary in connection with the work performed by the BNSF and the City's contractors, at City cost; and

WHEREAS, on December 17, 2012, by Roll Call No. 12-1913, City Council approved and authorized execution of the construction and flagging agreement with Norfolk Southern Railway Company; and

WHEREAS, on December 17, 2012, by Roll Call No. 12-1914, City Council approved and authorized execution of the contract of purchase for the partial acquisitions, temporary construction easements, permanent easement for roadway overpass, and total fee acquisition of property owned by NSR required for the Southeast Connector; and

WHEREAS, the City of Des Moines and NSR agree that an amendment to the construction and flagging agreement is necessary to provide right of entry to the property being purchased in the contract of purchase; and

WHEREAS, the amendment adds the NSR properties to Exhibit A of the construction and flagging agreement.

NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the First Amendment to the construction and flagging agreement (Norfolk Southern Railway Company) in connection with the Southeast Connector Project, be and is hereby
