Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines,

Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000,

as heretofore amended, is hereby amended by amending Sections 114-610, 114-612, 114-2704, 114-2761, 114-3249, 114-3425, 114-3427,

114-3556, 114-3915 and 114-3925.5, relating to traffic and vehicle

Sec. 114-610. School passenger loading and unloading zones.

regulations, as follows:

- (a) When signs are erected giving notice thereof, no person shall park any vehicle for other than the purpose of loading or unloading school passengers at any time or at the times specified in this section at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction:
 - (1) School passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days.
 - (2) School passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days; no parking at all other times.
 - (3) School passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days, 20 minutes only; no parking at all other times.
 - (4) School passenger loading and unloading, 7:00 a.m. to 9:00 a.m. school days, 20 minutes only.
 - (5) School passenger loading and unloading, 2:00 p.m. to 4:00 p.m. school days, 20 minutes only.
 - (6) School passenger loading and unloading, 7:00 a.m. to 4:00 p.m. school days, 30-minute limit.
 - (7) School passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 1:00 p.m. to 4:00 p.m., 30-minute limit.
 - (b) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-612. Passenger loading and unloading zones.

(a) When signs are erected giving notice thereof, no person shall park any vehicle for other than the purpose of loading or unloading passengers at any time or at the times specified in this section at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction:

(1) Passenger loading and unloading, 7:00 a.m. to 6:00 p.m., Monday through Friday.

(2) Passenger loading and unloading, 7:00 a.m. to 6:00 p.m., Monday through Friday, 20 minutes only.

(23) Passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday through Friday.

(34) Passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., 20 minutes only, Monday through Friday.

(45) Passenger loading and unloading, ten minutes only.

- (6) Passenger loading and unloading, 7:00 a.m. to 6:00 p.m., 20 minutes only.
- (b) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-2704. Tenth Street--Walnut Street to Locust Street.

Tenth Street, on the west side, from a point 28 feet north of Walnut Street to a point 130 feet north thereof, no parking 7:00 a.m. to 9:00 a.m.

Tenth Street, on the west side, from Locust Street to a point 30 feet south thereof, no parking any time.

Tenth Street, on the west side, from Walnut Street to a point 28 feet north thereof, no parking any time.

Tenth Street, on the east side, from Walnut Street to Locust Street, no parking 4:00 p.m. to 6:00 p.m.

Sec. 114-2761. East Fifteenth Street--East Vine Street to East Ovid Avenue.

East Fifteenth Street, on the east side, from a point 470 feet south of East Vine Street to East Court Avenue, no parking any time.

East Fifteenth Street, on the west side, from East Court Avenue to Dean Avenue, no parking any time.

East Fifteenth Street, on both sides, from Dean Avenue to Maple Street, no parking any time.

East Fifteenth Street, on the west side, from Maple Street to
