WHEREAS, the 1998 Quality Housing and Work Responsibility Act requires Housing Agencies to develop and submit to the U.S. Department of Housing and Urban Development (HUD) a one year Agency Plan; and

WHEREAS, the Agency Plan serves as the operational, planning and management tool for the Des Moines Municipal Housing Agency (DMMHA), including a mission statement of the goals and objectives of the Agency to serve the needs of low and moderate income families; and

WHEREAS, the one year plan with an effective ending date of July 1, 2013 contains specific operational information including an Application for a Capital Improvements grant; and

WHEREAS, the Public Housing Admissions and Continued Occupancy Policy, the Public Housing Lease Agreement, the Section 8 Administrative Plan, and the Family Self-Sufficiency Action Plan have been revised; and

WHEREAS, the plans were developed by City staff and the Housing Services Board during two working sessions open to the public, held on the following dates: November 21, 2012 and January 16, 2013; and

WHEREAS notice of the date and location of public hearings and the location of the availability of the "draft" plans was published in the Des Moines Register on January 17, 2013 and on the City's website; and

WHEREAS, in January 2013 all Public Housing residents and Section 8 clients received notifications of the availability of the draft documents for their review and comment; and

WHEREAS, the Director's Resident Advisory Board met with the Public Housing Board on November 21, 2012 and January 16, 2013 to review the Agency Plans; and

WHEREAS, at its meeting on March 13, 2013 the Housing Services Board held a formal public hearing to receive public comment on the Agency Plan and at the close of the public hearing, the Housing Services Board voted to approve and recommend the Agency Plan to the Municipal Housing Governing Board for its approval and submission to HUD.
